An excerpt from the email sent to some of us in November 2017 where the above link was contained:

A friend of mine, who belongs to his membership organization I.D.E.A., was recently on his seminar cruise out of Florida. He was present for the conference part of it at the hotel during the weekend, and boarded the cruise ship prior to it leaving, but was then removed from the ship and was never seen again throughout his own entire event. Members heard him being paged on the ship and saw him being questioned by security before being escorted off.

Members were told by staff that he fell ill, but there was talk of something more serious than that among some members. Hearing whispers of legal trouble, a few of us did a search online for him in

Florida and discovered he had actually been arrested for sneaking narcotics onto the cruise ship and was subsequently taken into custody missing his own business seminar.
